<p>Art. 2. DURATION</p>	<p>The course lasts one year and 1550 hours: 400 hours teaching (lectures) 700 hours individual learning activity 400 hours stage</p>																								
<p>Art. 3. UNIVERSITY CREDITS</p>	<p>60 University credits</p>																								
<p>Art. 4. COURSE OBJECTIVES AND PROFESSIONAL SKILLS</p>	<p>OBJECTIVES: The course aims at offering useful skills for the management of cultural organisations and heritage. Furthermore, the course aims at promoting the exchange of experiences and professional competence among students coming from different countries.</p> <p>PROFESSIONAL SKILLS: Providing students with specific knowledge and skills directed towards the development and improvement of cultural services and activities, the course adopts innovative teaching</p>																								

methodologies in an international perspective. The various taught courses are organized paying particular attention to methods of knowledge transfer, to contents and to experimentation, with a methodological approach and an organizational impact that intertwine theory and practice. In this way, the Course offers specific case-studies, in important Italian cultural institutions and organizations, and a whole session taught at the Deutsches Museum (Munich - Germany). Through a direct experience, the case-studies allow students to study and analyze the management profiles and organizational issues of the cultural subjects addressed during the course.

The course is designed for a national and international audience, for graduates already working in cultural institutions, and for people who would like to improve their preparation in the fields of management of cultural institutions. It provides students with useful knowledge to reshape and complete both their professional and their academic training in the field of management of cultural organizations, paying attention to the international background.

**Art. 5. SCHEDULE OF THE COURSE**

The course will start on February 28th, 2012, at 2.00 p.m at the Department of Economics, Via Voltapaletto,11 – FERRARA.

**SCHEDULE**  
From February 28<sup>th</sup> 2012:

The lessons will take place on Wednesday, Thursday and Friday, for a total amount of 24 hours a week, scheduled as follows: - March 2012: 4 modules; - April 2012: two modules; - May 2012: three modules; - June 2012: two modules; - October 2012: three modules. Each month there will be a "case study session" that will be organized as follows: a) introduction and presentation of the case and its context at the University of Ferrara, b) site visit and discussion with the directors of the companies and/or cultural institutions involved, c) the following week, discussion and group work on the case analyzed at the University of Ferrara. The cases to be analyzed are: - Florence, Uffizi Gallery and Museum of the Innocenti - Venice Biennale - in Parma, the Teatro Regio and the monuments of the Cathedral and Baptistery - Verona, Castelvecchio Museum and the Arena - Ferrara, Castello Estense, Palazzo dei Diamanti, Palazzo Schifanoia, the Municipal Theatre and the Park of the Po Delta

From June 19<sup>th</sup> to 26<sup>th</sup> 2012

During this week students will attend a specific module of the course in Munich (Germany) at the Deutsches Museum, the largest science museum in Europe.

In November the 14<sup>th</sup> and 15<sup>th</sup> 2012, the final dissertation of the master will be presented and discussed.

	<p>There will not be any intermediate test.</p> <p>There will be a Final Examination: the candidates will discuss their work on the research activities they carried out during the course or during the internship period. The thesis should address one of the topics analyzed during the course.</p> <p>The final presentation is scheduled on November the 16<sup>th</sup> 2012.</p> <p>Students who will not pass the test at the end of the course will not get the master's degree.</p> <p>Before the final exam, students will be asked to fill out a questionnaire .</p>
ART. 8. PREREQUISITES	<p>Applicants should have on of the following qualifications, issued by an Italian University:</p> <ul style="list-style-type: none"> <li>- laurea (D.M. 509/99)</li> <li>- laurea (D.M. 270/04)</li> <li>- laurea “ante riforma”</li> <li>- <b>Equivalent qualifications, as required by the law</b></li> </ul> <p>Call for application is open also to prospective students who have a foreign diploma recognized as equivalent by an Italian academic authority. The candidates having a foreign diploma (in the following areas: economics, law, humanities, social sciences, science, engineering, architecture-design), not recognized by an Italian academic authority, should be, according to the Ministerial rules for admission of foreign students in Italy, accompanied by an official translation in Italian, which has been legalised, and by the “Dichiarazione di valore in loco” (statement of compatibility evaluation).The Italian Consulate/Embassy in the country in which the degree was received should be contacted in order to complete the whole procedure. In this case the board of the course will evaluate the degree only for limited purposes for the course.</p> <p>The Director of the course can admit candidates with a qualification in a different area.</p> <p>The Rector of the University can, at any moment, rule on the exclusion of the student due to the lack of the above requirements.</p>

Art. 10. MAXIMUM NUMBER OF STUDENTS	<p>The course is open to a maximum of 25 students, including 5 seats reserved for students coming from a non EU country</p>

Art. 12.
